Nagar (Mohali), Punjab imposing a penalty of Rs. 5,24,308/- under section 73 of PGST/CGST Act, 2017 in relation to the ITC claimed on purchases from cancelled dealers, return defaulters & tax non-payers during Financial Year 2019-20.
